

The Clinton Health Access Initiative with funding from Unitaid is preparing to implement a liquid oxygen (LOX) supply chain model to explore the effectiveness of an alternative supply chain in Douala, Cameroon to supplement existing oxygen sources. This supply chain is proposed to begin with the procurement of VIE tank and Vaporizer. An Air Separation Unit (ASU) filled with LOX sourced from any cost-effective source is trucked and shipped to Limbe Regional Hospital.



CHAI invites interested and capable vendors to submit bids for the supply of one or more of the following products required for the supply scheme proposed above: Procurement of a VIE tank, vaporizer and the Installation, testing and commissioning as detailed in the specification package detailed in Annex B of this

ITB. When preparing your submission please be guided by the product details attached as Annex A, and CHAI code of conduct and ethics for suppliers in Annex C.
