The Ministry of Health, its agencies, developing partners and key stakeholders developed the National Medical Oxygen Policy to establish a framework and lay the foundation for a national strategy for scaling up production, availability, access, and use of medical oxygen across the country. The Policy seeks to create an enabling environment for the installation of oxygen sources and piping infrastructure to safely deliver oxygen to patients and to develop systems for oxygen infrastructure for the production, storage, distribution, and delivery of oxygen, including at the facility level.

The Clinton Health Access Initiative (CHAI) with funding from Unitaid as part of its ongoing efforts to increase access to medical oxygen invites interested and capable vendors to submit bids for the supply of a VIE system (tank and ambient vaporizer), civils, and related installation and commissioning services including medical liquid oxygen (LOX) supply for operational first fill for Police Hospital, Ghana as detailed in the specification package (Annex B) of this RFP. When preparing your submission please be guided by the product details attached as Annex A, specifications attached as Annex B, and CHAI code of conduct and ethics for suppliers in Annex C.

Vendors may be requested to submit additional information and/or cooperate with a site visit from CHAI to the mLOX production site prior to finalizing a purchase order.
